# **Public Policy**

Our Public Policy Committee informs statewide members of national initiatives and legislation in Hawai'i. These initiatives support our mission of advancing equity for women and girls and speak to women's needs, aspirations and concerns across their life span. We actively support bills in our legislature related to women's issues. The Legal Advocacy Fund (LAF) provides funding for women seeking judicial redress for gender discrimination.

### **Scholarship Program**

Windward Branch annually awards college scholarships to Windward women with priority given to women of diverse and disadvantaged circumstances or returning to higher education after a hiatus. The first scholarship was awarded in 1970 and has grown to include 329 grants and scholarships totaling \$358,590, given to women who will become tomorrow's leaders.
